






2012 Activities/ Roberts Bottom:

-January, 2012: install 11 shallow ground water wells (6-8' deep). These wells are checked monthly to assess seasonal variations of the local water table.

-Spring/ Summer/ Fall, 2012: Continue herbicide treatments by Grand County Weed Dept as needed.

-Spring/ Summer, 2012: Continue monitoring and assess future treatment needs.

-Fall, 2012: Drill Seed and/ or planting projects as necessary. We expect several years of retreatment to complete our restoration efforts.
