


Long-term Funding Strategies

- Develop a Funding Plan that outlines a strategy for pursuing different fund streams over the coarse of the next 5 years
- Ask the BLM to replenish Assistance Agreements
- Work with Partners for Fish and Wildlife to renew Species Conservation Trust Fund
- Work with Community Foundations to create an endowment or pass-through fund
- Solicit major donations and leverage them through a fund
- Other Ideas?



- Firm up budget estimates for 2014 2018
- Meet with department heads e.g. BLM State Director
- Applying for traditional and new grants e.g.
 Daniels Fund, Desert Ecosystems Analysis and Restoration, NAWCA...
- Figure out major donor fundraising strategy developing a strawman
- Recruit more participants to join the FSC
